In the identified area, the current year population is 92,560. In 2010, the Census count in the area was 89,193. The rate of change since 2010 was 0.33% annually. The five-year projection for the population in the area is 94,346 representing a change of 0.38% annually from 2021 to 2026. Currently, the population is 48.9% male and 51.1% female.

Median Age

The median age in this area is 47.5, compared to U.S. median age of 38.5.

Current average household income is \$166,615 in this area, compared to \$90,054 for all U.S. households. Average household income is projected to be \$183,129 in five years, compared to \$103,679 for all U.S. households

Current per capita income is \$62,444 in the area, compared to the U.S. per capita income of \$34,136. The per capita income is projected to be \$68,581 in five years, compared to \$39,378 for all U.S. households

Currently, 60.4% of the 36,668 housing units in the area are owner occupied; 34.4%, renter occupied; and 5.3% are vacant. Currently, in the U.S., 57.3% of the housing units in the area are owner occupied; 31.2% are renter occupied; and 11.5% are vacant. In 2010, there were 35,436 housing units in the area - 62.2% owner occupied, 32.4% renter occupied, and 5.5% vacant. The annual rate of change in housing units since 2010 is 1.53%. Median home value in the area is \$515,979, compared to a median home value of \$264,021 for the U.S. In five years, median value is projected to change by 1.93% annually to \$567,593.
